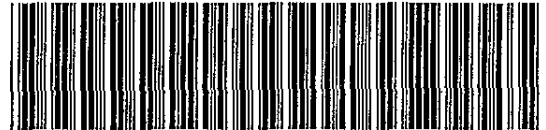



**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of E-Media Business Group USA, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**


