ARTICLES OF INCORPORATION

The undersigned Incorporator hereby executes these Articles of Incorporation for the purpose of forming a professional corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I  
NAME

The name of this Corporation shall be:

DOUGLAS SCOTT STAFFORD, D.M.D., P.A.

ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of this Corporation shall be 1619 Dawnridge Court, Brandon, Florida 33510.

ARTICLE III  
CAPITAL STOCK

1. Authorized Capitalization. The total number of shares of capital stock authorized to be issued by this Corporation shall be Ten Thousand (10,000) shares of common stock, par value \$1.00 per share (the "Common Stock").

2. Payment for Stock. All or any part of the consideration for the issuance of the capital stock of this Corporation may be in cash, property, or labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for that purpose, which consideration, in any event, shall not be less than the par value of the shares issued therefor. All stock when issued shall be fully paid and nonassessable.

3. Voting. The voting power of this Corporation shall be vested solely in the Common Stock. Holders of shares of Common Stock shall be entitled to one vote for each share of Common Stock. There shall be no cumulative voting in the election of Directors.

4. Dividends. Any and all dividends are to be shared among the holders of shares of outstanding Common Stock on a share for share basis.

This Corporation shall have perpetual existence.

ARTICLE V  
REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of this Corporation shall be located at 1619 Dawnridge Court, Brandon, Florida 33510, and the initial registered agent of this Corporation at such office shall be DOUGLAS SCOTT STAFFORD, D.M.D. This Corporation shall have the right to change such registered agent and such registered office from time to time, as provided by law.

ARTICLE VI  
BOARD OF DIRECTORS

The Board of Directors of this Corporation shall consist of a number of Directors to be fixed from time to time by the stockholders or the bylaws. The business and affairs of this Corporation shall be managed by the Board of Directors, which may exercise all such powers of this Corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by the stockholders.

ARTICLE IX  
BUSINESS AND PURPOSES

The general purpose for which this Corporation is organized is to engage in the practice of dentistry through its agents, officers, and employees who are duly licensed or otherwise legally authorized to render those professional services within the State of Florida. This Corporation shall not engage in any business other than the practice of dentistry.

ARTICLE X  
BYLAWS

(a) The Bylaws of this Corporation shall be for the government of this Corporation and may contain any provisions or requirements for the management or conduct of the affairs and business of this Corporation, provided the same are not inconsistent with the provisions of these Articles of Incorporation, or contrary to the laws of the State of Florida or of the United States of America.

(b) The Bylaws of this Corporation shall be adopted by the Board of Directors; provided that any bylaw or amendment thereto as adopted by the Board of Directors may be altered, amended or repealed by vote of the stockholders entitled to vote thereon, or a new bylaw in lieu thereof may be adopted by the stockholders, and the stockholders may prescribe in any bylaw made by them that such bylaw shall not be altered, amended or repealed by the Board of Directors.

AMENDMENT OF ARTICLES OF INCORPORATION

This Corporation reserves the right to amend, alter, change, or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the stockholders herein are subject to this reservation.

ARTICLE XII  
AFFILIATED TRANSACTIONS

The provisions of Section 607.0901, Florida Statutes, relating to affiliated transactions, shall be inapplicable to this Corporation.




