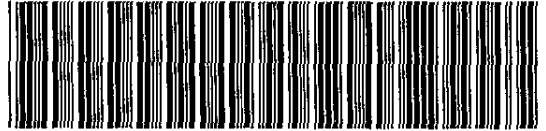

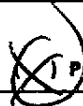

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida

ARTICLE I – CORPORATE NAME

TURZEYS International, Inc.

ARTICLE II – DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III – PURPOSE

The corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The corporation is authorized to issue 100 shares of dollar(s) (\$10.00) par value Common Stock, which shall be designated "Common Shares".

ARTICLE VIII

The members of the Board of Directors shall never be less than two (2) in number. A tie vote shall be in the favor of the President Domestic.

ARTICLE IX

These Articles of incorporation may be amended by a majority vote of the Board of Directors at any special meeting called for that purpose, after first giving at least ten (10) days written notice of the meeting. Amendments to the Articles of incorporation shall only be effective from the date of approval in writing by the Chairperson of the Board.

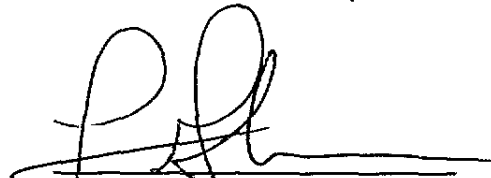
ARTICLE X

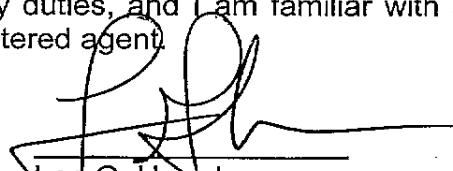
