The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is THE FANCY FROG, INC.

ARTICLE II - Principal Office and Mailing Address of the Corporation

The address of the principal office of the corporation is 1411 Briarwood Lane, Lakeland, Florida, 33803 and its mailing address is 1411 Briarwood Lane, Lakeland, Florida, 33803.

ARTICLE III - Commencement and Duration

The corporation is to commence its corporate existence effective immediately, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE VII - Board of Directors

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors.

The corporation shall have two (2) directors initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.

The names and street addresses of the initial directors who shall hold office until theirs successors, who shall be chosen at the first meeting of the stockholders have qualified, shall be:
