DURATION:

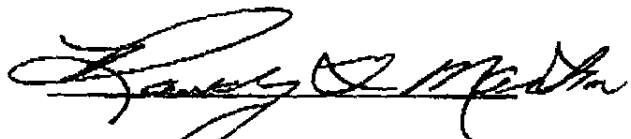

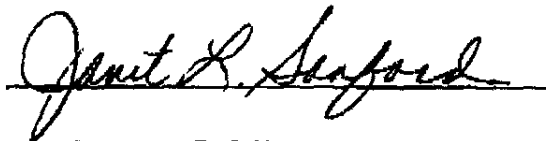

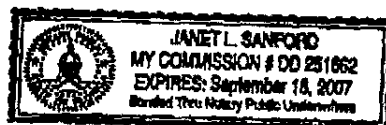
