being at least eighteen years of age, pursuant to Chapter 621, F.S. do hereby form a for profit corporation under the laws of the State of Florida.

SECOND: The name of the corporation is: FaithWorks Mortgage Group, Inc.

THIRD: The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the laws and statutes of the State of Florida.

The primary objectives of our organization are to:

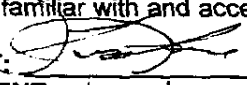
