



**ARTICLES OF INCORPORATION OF
B&B GLOBAL, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the corporation is B&B Global, Inc. The principal place of business and mailing address of the corporation is 12843 NW 23rd Street - Pembroke Pines, Florida 33028.

ARTICLE II - SHARES

The corporation shall have the authority to issue 10,000 shares of stock. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.
