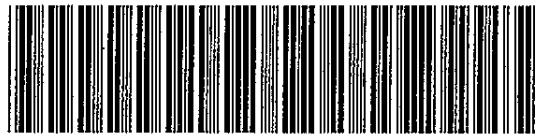

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby sets forth his intention to form a corporation under the laws of the State of Florida.

Article 1. Name. The name of this corporation is **CHARLIE DEAN TOWERS, INC.**

Article 2. General Purpose. This corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

Article 3. Capital Stock. This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

Article 4. Registered Office and Agent. The street address of the principal place of business of this corporation is **10032 Brompton Drive, Tampa, Florida 33626**, and the name of the initial registered agent of this corporation is **Charles S. 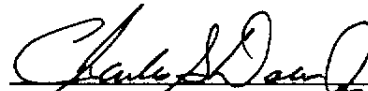
Article 7. By-Laws. The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and Shareholders of this corporation.
