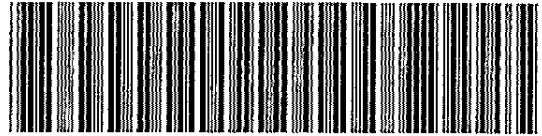



I, the undersigned, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the State of Florida providing for the formation, liabilities, rights, privileges and immunities for a corporation for profit.

Limitations of Corporate Stocks.

No shareholder of this Corporation may sell or transfer stock in this Corporation except to another individual who is eligible to be an stockholder in the Corporation, and such sale or transfer may be made only after the same shall have been approved at a stockholder's meeting specially called for that purpose by not less than a majority of the outstanding stocks at such stockholder's meeting, exclusive of the stock to be sold. The stockholders voting at such meeting shall have first option to purchase the shares from the selling shareholder, the shares of stock held by the shareholder proposing to sell or transfer his shares may not be voted or counted for any purpose at said meeting.

ARTICLE XI

The Corporation shall have the further right and power to, from time to time, determine whether and what extent, at what time and places and under what conditions and regulations the accounting books of this Corporation, other than the stock book, or any of them, shall open to the inspection of the stockholders, shall have any right of inspecting any
