



ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is CMS International Group, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall 900 S.W. 40th Avenue Plantation, Florida 33317

ARTICLE III - PURPOSE
