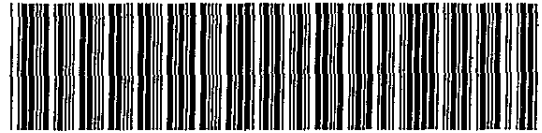





The undersigned, for the purpose of forming a for-profit Corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

**Article I  
Name**

The name of the Corporation shall be L & D National Professional Business Associates, Inc., (hereinafter called the "Corporation").

**Article II  
Principal Office and Mailing Address**

The principal office and mailing address of the Corporation is 1362 N. Mangonia Drive, West Palm Beach, Florida 33401.

**Article III  
Purpose**

The Corporation is a for-profit organization, organized for the purpose of engaging in lawful act or activity for which for profit Corporations may be organized, so for as is or may be permitted by laws of the State of Florida. 
