
**ARTICLE VIII

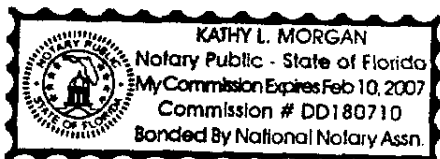
