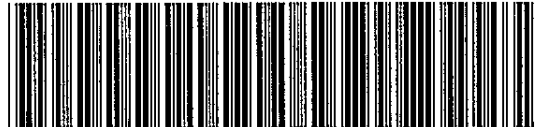

**ARTICLES OF INCORPORATION
OF
STEVEN F. JACOB & ASSOCIATES, INC.**

ARTICLE I - NAME

The name of this corporation is STEVEN F. JACOB & ASSOCIATES, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

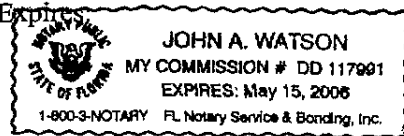
