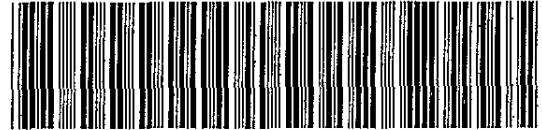

**ARTICLE I: NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **Floyd Wilkie Enterprises,, Inc.** and its principal place of business shall be located at **P.O. Box 1516, Trenton, Florida 32693.**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
