ARTICLES I - NAME

This name of this organization is Sterling Home Inspections, Inc.





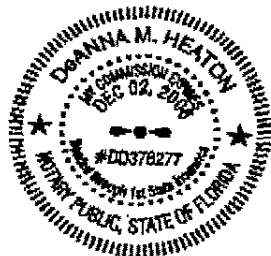
