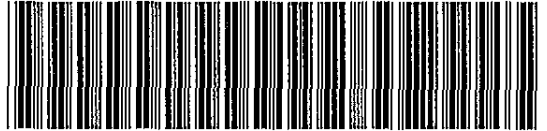

BY THESE ARTICLES the incorporator forms a corporation under the Business Corporations Act:
