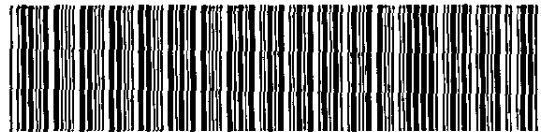

**THE UNDERSIGNED**, acting as sole incorporator of FLORIDA TRACTORS.COM, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

### **Initial Board of Directors**



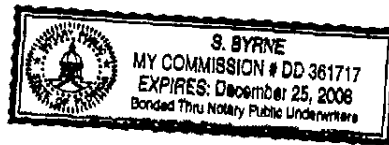
