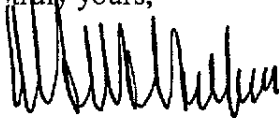

**ARTICLE I- NAME AND ADDRESS**

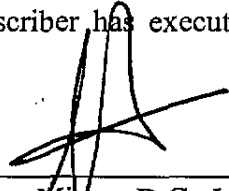

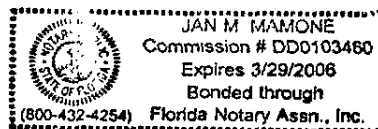

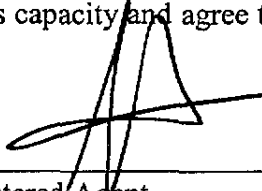
