WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

FIRST: The name of the corporation is FIVE STAR FENCE OF CENTRAL FLORIDA, INC.

SECOND: The period of its duration is Perpetual

THIRD: The purpose(s) for which the corporation is organized are "To operate a fence company and any other lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes."
