

# ARTICLES OF INCORPORATION

# **OF**

# GRCR Management, Inc.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Corporation under the laws of the State of Florida.

#### ARTICLE I

#### NAME

The name of this Corporation is GRCR Management, Inc.,

### **ARTICLE II**

### **PURPOSE**

This Corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.


