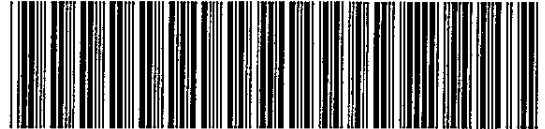

ARTICLES OF INCORPORATION

OF

DIVINE INSPIRATIONS & IMPRESSIONS, INC.

The undersigned, acting as incorporator of **DIVINE INSPIRATIONS & IMPRESSIONS INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is DIVINE INSPIRATIONS & IMPRESSIONS INC.

ARTICLE II. ADDRESS

The mailing address of the corporation is 12951 SW 17TH COURT, MIRAMAR, FLORIDA 33027

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon the filing of these articles of incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 12951 SW 17th Court, Miramar, Florida 33027 and the name of the corporation's initial registered agent at that address is Valerie B. Ward.

ARTICLE VII. INCORPORATOR

The name and street address of the incorporator is Anthony B. Jackson Sr., 4440 NW 168th Terrace, Carol City, Florida 33055.

The incorporator of the corporation assigns to this corporation his rights under Section 607.0201, Florida Statutes, to constitute a corporation, and he assigns to those persons designated by the board of directors any rights he may have as incorporator to acquire any of the capital stock of this corporation, this assignment becoming effective on the date corporate existence begins.


ARTICLE VIII. BYLAWS
