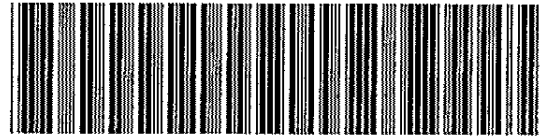

ARTICLE OF INCORPORATION  
OF  
KurVine, Inc.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE  
NAME

The name of the corporation is KurVine, Inc.

ARTICLE TWO  
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE  
PURPOSE

The purpose for which the corporation is organized is to provide grading and land clearing services for profit.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

CAPITAL STOCK

The board of directors reserves the right to amend these Articles of Incorporation from time to time and in any respect as may be desired.


