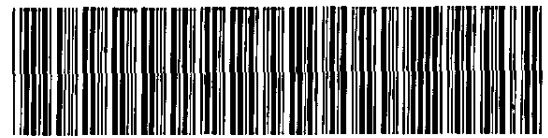


PREEMPTIVE RIGHTS:
