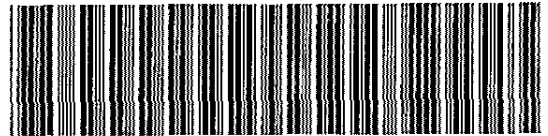

**ARTICLES OF INCORPORATION
OF
SCC INVESTMENT CORPORATION**

The undersigned, for the purpose of forming a corporation for profit under Florida law, adopt the following articles of incorporation:

ARTICLE ONE: NAME

The name of the corporation is SCC INVESTMENT CORPORATION

ARTICLE TWO: DURATION

This corporation shall exist perpetually.
