The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby present these Articles for the formation of a corporation in accordance with the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is TEGGE MARINE, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

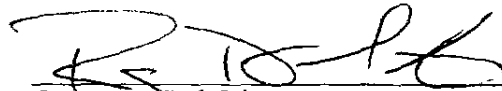
