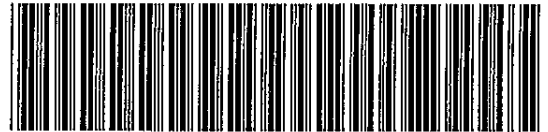




ARTICLE IX
