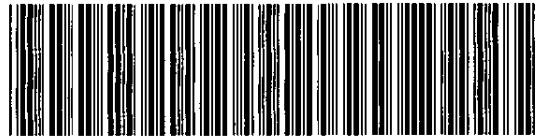

Gaston Nunez-Cardenas is hereby deleted as Registered Agent of the Corporation.


Maday Acosta shall be the Registered Agent of the corporation at 2309 West Martin Luther King Boulevard, Suite 3, Tampa, Florida 33607.




