## INSPECTION OF BOOKS AND RECORDS


## ARTICLE XII

### AMENDMENTS





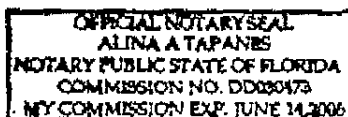


