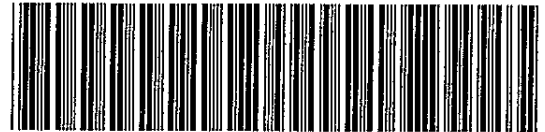

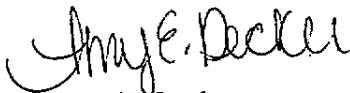

ARTICLE I. CORPORATION NAME

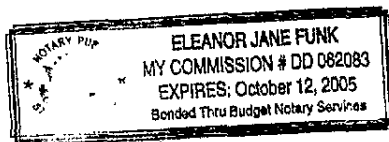

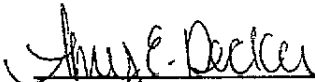

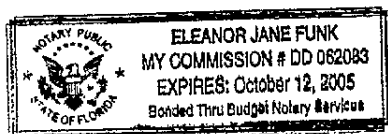
