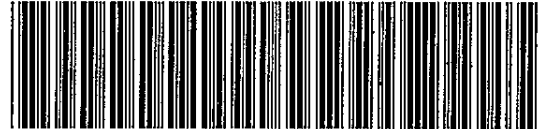

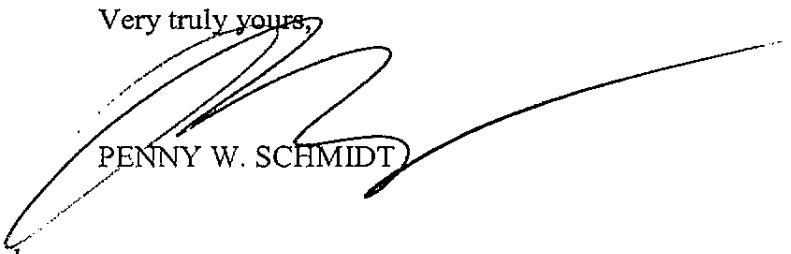

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I  
NAME

The name of the corporation is Bulk Vending Corporation, Inc.

ARTICLE II  
PRINCIPAL OFFICE

The street address and mailing address of the initial principal office of the corporation is 5398 Heronview Ct. Jacksonville, Florida 32257 (Street) and P.O. Box 56952 Jacksonville, FL 32241-6952 (Mailing).

ARTICLE III  
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE IV  
PURPOSES OF CORPORATION

The general purposes for which the corporation is organized are:

1. To engage in the primary business of Bulk Product Vending in the state of Florida and;
2. To engage in any other lawful business as permitted under applicable law and general rules and regulations in the United States.

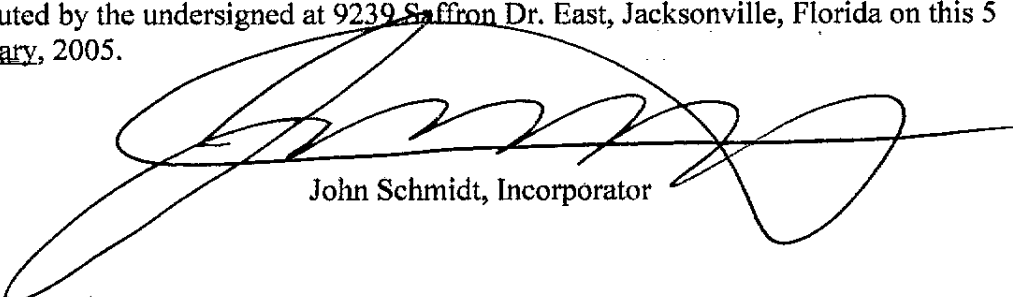
ARTICLE VII

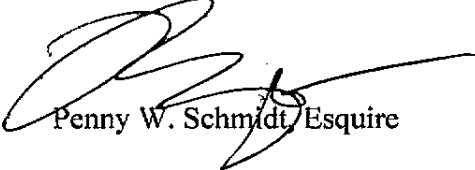
