

# CERTIFICATE OF INCORPORATION

## R.A.M.D. CORPORATION

I, the undersigned, do hereby subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

# ARTICLE ONE
