ARTICLE I - NAME

The name of this Corporation is: JUAN CARLOS MEZA PAINTING SERVICES INC.

ARTICLE II - DURATION

This Corporation is to exist perpetually. It shall commence existence on the date of filing of these Articles of Incorporation.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK
