

OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is **S.J. CASTINGS and SUPPLIES, INC.**

The term of duration of the corporation is perpetual.






