1. The provisions of Article I are deleted in their entirety and a new Article I is inserted in lieu and in place thereof, which new Article I shall read as follows:


**Article I**

- (5) The Affiant represents that she has authority to execute this release for and in behalf of the Company.

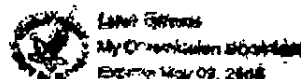
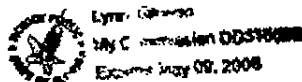
