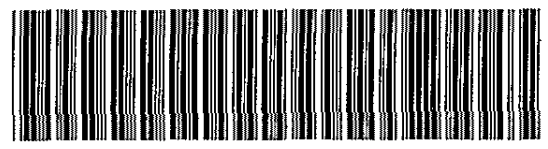

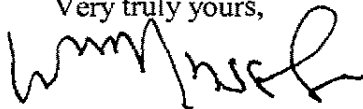

The undersigned subscriber, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under Chapter 607 and Chapter 621, Florida Statutes.

**ARTICLE I**  
**CORPORATE NAME**

**AMENDMENT**

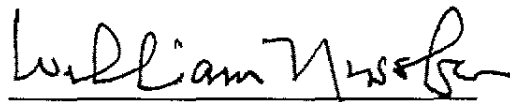
