ARTICLE I

The name of this corporation is **HOME SAVERS PLUS, INC.**

ARTICLE II

The corporation is to exist perpetually, commencing on the date of filing and recording of these Articles.

ARTICLE III

This corporation is organized for the purpose of real estate sales and rentals and any other legitimate business.

ARTICLE IV
