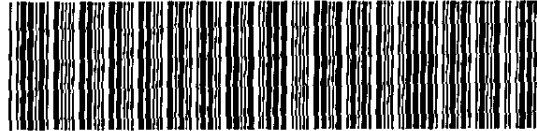

ARTICLES OF INCORPORATION
OF
R AND R NEW CREATION INC.

ARTICLE I

The name of this corporation is R AND R NEW CREATION INC.



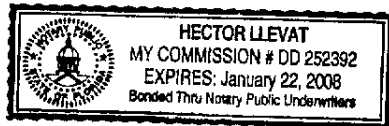
