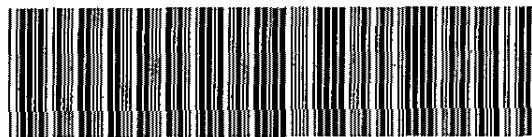


Article IX – Indemnification


