



Articles of Incorporation (

Article I

Name

The name of this corporation is Noor Service, Inc.

Article II

Principal Office

The Street Address of the initial principal office of this corporation is 422 East Sample Rd. Pompano Beach, FL 33442. The Board of Directors may, from time to time, change the street and post office address of the corporation as well as the location of its principal office.

Article III

<u>Purpose</u>

This corporation is organized for the following purpose:
