

ARTICLES OF INCORPORATION
OF

ARTICLE I • NAME

The name of this Corporation is American Investments of Brevard, Inc. The principal office mailing address is P.O. Box 2051, Melbourne, FL. 32901.

ARTICLE II • DURATION

This Corporation shall exist perpetually commencing on April 1, 2005.

The power to adopt, amend, alter, rescind or repeal the By-laws shall be vested in the Board of Directors and the shareholders.


ARTICLE X • POWERS




