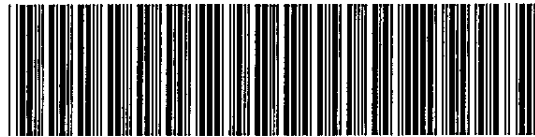

The name of this Corporation is ORIFICE LAND DEVELOPMENT CORP.

ARTICLE II - NATURE OF BUSINESS


