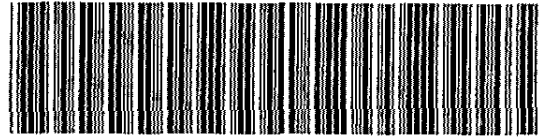

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is P.I. Babs Investigations, Inc.

The duration of the corporation is perpetual.

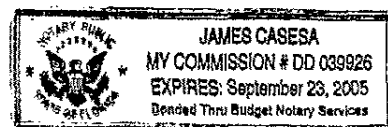
