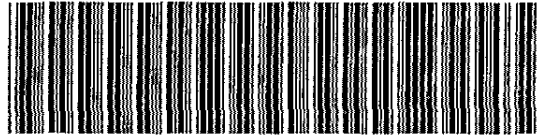

The undersigned, acting as Incorporator of a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

1. NAME. The name of the corporation is GARY D. LABRIOLA, P.A.

2. PRINCIPAL OFFICE/MAILING ADDRESS. The principal office and mailing address of the corporation is 8899 N.W. 70th COURT, PARKLAND, FLORIDA 33067.

3. SHARES. The number of shares the corporation is authorized to issue is one hundred (100) shares. The par value for the authorized shares is One Dollar (\$1.00).

4. PREEMPTIVE RIGHTS. 


