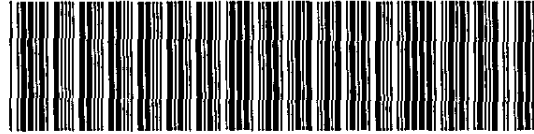



ARTICLES OF INCORPORATION
OF
CONSTRUCTION SERVICES INC. OF THE SUNSHINE
STATE

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE I

The name of this corporation shall be: Construction Services Inc. of the Sunshine State

The duration of the corporation shall be perpetual.

ARTICLE III

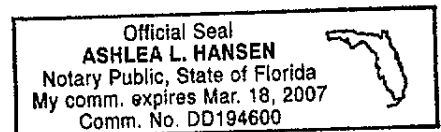
