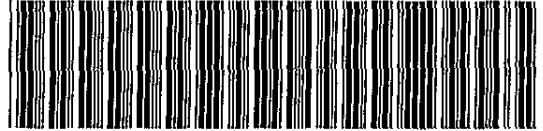

Article I.

The name of the Corporation is **2331 RENOVATIONS, INC.**

Article II.

This Corporation shall have perpetual existence, and shall commence upon the signing and acknowledging of these Articles.

Article III.
