# ARTICLES OF INCORPORATION OF BAY PARK GROUP CORP.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

#### **ARTICLE I - Name**

The name of the corporation is BAY PARK GROUP CORP. (the "Corporation").

#### ARTICLE IV - Registered Office and Agent


