#### ARTICLE IX

(a) **BOARD OF DIRECTORS**: The powers of this corporation shall be exercised, it's properties controlled and it's affairs conducted by a board of directors. The board of directors is hereby authorized to obtain directors and officers liability insurance covering acts heretofore and hereafter occurring and to pay for same from funds of the corporation.

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled, nor shall anything herein contained restrict the right of the corporation to indemnify or reimburse such person in any proper case even though not specifically herein provided for.
