- 1. Name. The name of the corporation is: ROGER B. ALDOUS, INC.
- 2. Purpose. The corporation may engage in any legal business.
- 3. <u>Stock</u>. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 100 shares of common capital stock with no par value.
