#### ARTICLES OF INCORPORATION

OF

We, the undersigned, hereby associateourselves for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

## ARTICLE I

The name of the corporation shall be:

#### ARTICLE II

#### NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The number of directors may be increased or decreased from time to

The corporation shall indemnify and hold hamless each person who shall serve at any time bereafter as a director or officer of the corporation, and any person who serves at the request of the corporation, as a director or officer of any other corporation, from any against any and all claims and liabilities to which such person shall become subject by reason of this having heretofore or hereafter being a director or officer of the corporation, or by reason of any action alisged to have been heretofors or hereafter taken or omitted by him as such dire ctor or officer, and shall reimburse each such person of all legal and other expenses reasonably incurred by him in connection with any liability provided that no person shall be indemnified against, or be reimbursed for, any expenses incurred in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable for negligence or willful misconduct in the performance of bis duties.


