
ARTICLE SEVEN



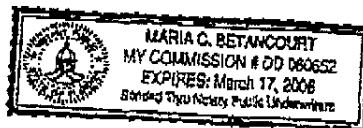


